Announcement of Proposed System Acquisition Plan

I am pleased to announce the following weapon system purchase plan in accordance with Article 8 of the Act on Contracts to Which the State is a Party and Article 213 of the Defense Acquisition Program Management Regulation 432.

■ Project Title : Maritime Operation Helicopter Batch-II Program

■ Project Description

This program intends to acquire Maritime Operation Helicopter to operate in the Republic of Korea Navy.

■ Qualification for Bidding Participation

- A participant that is qualified under Article 12 of the Enforcement Decree of the Act on Contracts to Which the State is a Party and who is not restricted by Article 76 of the foregoing Enforcement Decree.
- A participant who is not restricted by Article 70 of the Enforcement Decree of the Defense Acquisition Program Act.
- A foreign company that can manufacture or supply Maritime Operation Helicopter

■ Program Explanatory Session

- Date : 28 June, 2018 (14:00 ~ 16:00)

※ All participating companies must arrive at the information building of Government complex Gwa-cheon by 13:30.

- Contents

- Explanation and distribution of RFP

※ Distribution of RFP shall be limited to the participants of the explanatory session according to Article 43 of the Enforcement Decree of the Act on Contracts to Which the State is a Party and only those who participate in the explanatory session are eligible to participate in this program.

- Qualified participants for the explanatory session
 - Employees that satisfy all of the above qualifications for participation (Interpreter included)
 - Government Employees of participating company
- Notice
 - All participants in the explanatory session are required to submit their company name, position title, name, nationality, date of birth(or passport number), and phone number(or cell phone number) for his/her entrance to DAPA and prior security clearance, via FAX or POC's e-mail by the aforementioned date/time to DAPA (Maritime Aircraft Project Team).
 - Participation to the explanatory session is limited to pre-registered personnel only.

■ Contracting and Source Selection Method

- Contract Method : Overseas commercial purchase(Direct commercial sales)
- Contract Type : Open competition, Firm Fixed Price Contract
- Source Selection
 - The companies' proposals shall first be evaluated to select the eligible entities. DAPA shall then conduct T&E and negotiations on the selected system(s).
 - Once negotiations and T&E are completed, a source(contractor) shall be selected via a Comprehensive Evaluation Technique.

 - Article 43(Contract Through Negotiations) of the Enforcement Decree of the Act on Contracts to Which the State is a Party.

■ Proposal Submission(Bidding Registration Deadline)

- Submission method : On site submission(Not by mail)
- Required documents : Upon submission of the proposal
 - a. One(1) copy of Foreign Procurement Registration Certificate issued by DAPA

- b. One original copy of proof of the manufacturer(notarized)
- c. One original copy of proof of the supplier(notarized)
- d. One(1) a bid application
- e. One(1) Set of documents related to the Bid Bond by the name of the Corporation with the qualification to participate in the bidding(Refer to "Matters concerning the Bid Bond and Reversion to the National Treasury")
- f. One(1) copy of supply agreement with the target equipment manufacturer
- g. One(1) copy of Confirmation that a Domestic Commission Agent will not be used OR a Request for Use of Trade Agent
- h. One(1) Original copy of the Pledge of Integrity
- i. Two(2) copies of status of bidding assistants
- j. Other necessary documents(refer to Request for Proposal section-II for details)

■ **Bid-Bond and Reversion Guideline**

- Entities qualified for participation shall prepare 5% of the proposed price or more as the bid-bond to guarantee the implementation of its obligation upon its submission of the proposal.
- The proposing entity may be exempted from the bid-bond requirement if the following provisions do not apply. When exempt, the qualified proposing entity shall submit, upon its submission of the proposal, a Memorandum of Payment for Bid-Bond under the name of the proposing entity pursuant to Paragraph 2, Article 43 of Enforcement Decree of the Act on Contracts to Which the State is a Party.
 - ① An entity who has not yet made a payment due for reversion to DAPA
 - ② An entity who is currently prohibited from entering into an agreement with DAPA under Article 76 of the foregoing Enforcement Decree.
 - ③ An entity who was formed less than one(1) year before the date of registration deadline
- If the successful bidder fails to conclude the contract by the appointed date, the Bid-Bond shall come under the jurisdiction of the Nation by Article 9 of the Act on Contracts to Which the State is a Party and Article 38 of the foregoing Enforcement Decree.

■ **Invalidation of the Bidding**

A Bidding which falls under Enforcement Decree of the Act on Contracts

to Which the State is a Party Paragraph 4, Article 39 and Enforcement Regulation Article 44, and Commodity Purchase(Manufacturing) Bidders Annexes(Ministry of Strategy and Finance Regulation 329, 1 January, 2017) Article 12 shall be considered invalid.

■ Other Bidding Requirements

- Bidding participant(Company) shall submit a Pledge of Integrity and shall have full knowledge of the Special Terms and Conditions for Integrity Contract(Pledge). The Special Terms and Conditions for Integrity Contract(Pledge) will be attached to the contract upon contract award. The Pledge of Integrity and the Special Terms and Conditions for Integrity Contract(Pledge) can be found in RFP Volume 5.
- In the event that military secrets regarding this program is illegally released to the unauthorized party, the Bidding participant(company) shall suffer disadvantages and all responsibility shall lie with the Bidding participant(Company).
- The bidder shall have full knowledge of bidding documents, and the bidder shall be responsible for ignorance of such information.
- In case of any conflicts in interpretation of a proposal, the Korean version shall prevail
